Article II amended as follows.

This corporation does not contemplate pecuniary gain or profit, direct or indirect to its Members, and its primary purposes are:

A. To promote the health, safety and, social welfare of the owners of all Lots located within Tampa Palms Unit 4B The Sanctuary at Tampa Palms (the "Community"), a platted subdivision within Tampa Palms, a master planned community within Hillsborough County, Florida;

B. To maintain all portions of the Community and improvements thereon for which the obligation to maintain and repair has been delegated to the corporation by the Declaration of Covenants, Conditions and Restrictions of Tampa Palms Unit 4B The Sanctuary at Tampa Palms ("Declaration") which is to be recorded in the public records of Hillsborough County, Florida;
